Subclass (c) Replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity. The renovations or modernization of elevators 1 and 2 is considered a reconstruction for the County facility and is consistent with the Class 2(b)(c) exemption.
