Description of Nature, Purpose, and Beneficiaries of Project:

The police station was constructed approximately thirty-five (35) years ago and has seen a significant increase in staffing during that time. In order to accommodate the additional staffing, both sworn and non-sworn, it was determined that an area of the second floor above the first-floor reception, originally intended as a second floor reception area, could be extended over the first floor reception and reconfigured to accommodate additional workspace area. The expansion of the second floor will provide and additional 300 square feet of floor space bring the total available floor space to just over 900 square feet.
