Project Title: Seven Oaks and Radford Camp Roads Post-Fire Emergency Protection Measures in the Line Fire Scarred Areas

Project Location: Seven Oaks Area, unincorporated San Bernardino County

Project Description: On September 5, 2024, the Line Fire ignited in San Bernardino County, burning approximately 43,978 acres in the Santa Ana Watershed, including the Seven Oaks area. A Governor Proclaimed State of Emergency has been declared for San Bernardino County. Emergency work would involve road and slope repairs, clearing road culverts and bridges of sediment and debris, diverting active flows away from infrastructure, and any necessary grading to ensure storm flow conveyance through existing culvert and bridges.
