PROJECT LOCATION: The service contract area relates to Assessor Parcel Numbers (APNs) 0257-012-12, 0257-021-02, 0257-021-28, and 0257-031-35, encompassing a total of approximately 12.6 acres, generally located between Santa Ana and Solver Avenues, east of Linden Avenue, within the City of Rialto's southern sphere of influence in the unincorporated Bloomington community.

PROJECT DESCRIPTION: Authorization of a service extension agreement submitted by the City of Rialto to provide sewer service outside its boundaries to a proposed 181-unit multi-family condominium complex on the 12.6-acre project area.

This is to advise that the Local Agency Formation Commission for San Bernardino County (Commission), as responsible agency, has approved the above-described project and has made the following determinations regarding the project:

- 1. The project will not have a significant adverse impact on the environment.
- 2. A Negative Declaration, with mitigation measures included in the Conditions of Approval, was prepared by the County of San Bernardino as a function of its review for a Zone Change from RS-20M (Single Residential 20,000 Square Foot Minimum) to RM (Multiple Residential) in conjunction with a Conditional Use Permit and a Condominium Tentative Tract Map (TTM 20481) for a 181-unit multi-family condominium complex on the 12.6-acre project area. - 3. Mitigation measures included in the Conditions of Approval for the project approved by the County have been acknowledged by the Local Agency Formation Commission.
