I. CALL TO ORDER – The meeting was called to order by Mayor John Dutrey (Montclair), Chair of the City Select Committee.

IV. APPOINTMENT OF THE CITY SELECTION COMMITTEE CHAIR

Chair Dutrey stated that the purpose of the election was to fill the Chair position for the City Selection Committee for a term that will expire in May 2028. The Chair asked Lynna Monell to explain the process and conduct the election. Lynna Monell explained that there was one declared candidate, Mayor John Dutrey (Montclair), and nominations would be taken from the floor. No nominations from the floor were received. Mayor John Dutrey (Montclair) was appointed by a unanimous vote of the members present.

V. APPOINTMENT OF THE CITY SELECTION COMMITTEE VICE CHAIR

Chair Dutrey stated that the purpose of the election was to fill the Vice Chair position for the City Selection Committee for a term that will expire in May 2028. The Chair asked Lynna Monell to explain the process and conduct the election. Lynna Monell explained that there was one declared candidate, Acquanetta Warren (Fontana), and nominations would be taken from the floor. No nominations from the floor were received. Mayor Acquanetta Warren (Fontana) was appointed by a unanimous vote of the members present.

VI. APPOINTMENT OF ONE PRIMARY MEMBER OF THE LOCAL AGENCY FORMATION COMMISSION

Chair Dutrey stated that the purpose of the election was to fill the primary member position currently held by Mayor Phill Dupper (Loma Linda) for LAFCO for a term that will expire in May 2030. The Chair asked Lynna Monell to explain the process and conduct the election. Lynna Monell explained that there were two declared candidates, Phill Dupper (Loma Linda) and Mayor Pro Tem Doug Wilson (Grand Terrace), and nominations would be taken from the floor. No nominations from the floor were received. A roll call vote was conducted. Mayor Phill Dupper (Loma Linda) was appointed, by a majority vote of the members present.

VII. APPOINTMENT OF ONE ALTERNATE MEMBER OF THE LOCAL AGENCY FORMATION COMMISSION

Chair Dutrey stated that the purpose of the election was to fill the alternate member position currently held by Council Member Rick Denison (Yucca Valley) for LAFCO for a term that will expire in May 2030. The Chair asked Lynna Monell to explain the process and conduct the election. Lynna Monell explained that there were three declared candidates, Council Member Rick Denison (Yucca Valley), Mayor Pro Tem Curtis Burton (Chino), and Mayor Pro Tem Doug Wilson (Grand Terrace), and nominations would be taken from the floor. No nominations from the floor were received. A roll call vote was conducted. Council Member Rick Denison (Yucca Valley) was appointed, by a majority vote of the members present.
