**LOCAL AGENCY FORMATION COMMISSION (LAFCO)**

LAFCO is responsible for approving municipal and district boundaries which discourage urban sprawl and encourage orderly governmental boundaries based upon local circumstances and conditions. Commission membership consists of two city/town members selected by the City Selection Committee, two County Supervisors, two representatives of independent special districts, and one public member. The Commission normally meets for a half day on the third Wednesday of each month. Mayors and City/Town Council Members of the member cities/towns are eligible to serve on LAFCO. The selected Mayor(s) or City/Town Council Member(s) will serve a four-year term.

Historically, in selecting city/town representation on LAFCO, selections that provided for representation from the West Valley, East Valley, and Mountain/Desert regions were preferred.

Twenty-one years serving on the Grand Terrace Planning Commission and twelve years on the City Council exponentially magnified how important public relations are when working on behalf of the community. Over the course of more than forty-five years as a third-generation Builder and Land Development Professional, I advanced from Customer Service to Assistant Superintendent to Project Superintendent to Purchasing Agent by the age of twenty-eight. Regular interaction with jurisdictional staff and the public proved invaluable to progress. In 1984 a Newport Beach-based developer recruited me as a Project Manager for six-hundred three-story double subterranean townhomes and stacked flats in the City of Los Angeles, and a Master Planned residential project in Santa Clarita.

Along the way I attended the University of California at Irvine and obtained a Light Construction and Development Management (LCDM) certification that enhanced my team leadership, consultant management, issue resolution, public hearing, goal achievement, status reporting, and due diligence skills; resulting in an eventual promotion to Vice President of Operations specializing in forward planning, entitlement, land acquisition pre-purchase feasibility, fast track scheduling, cash flow projections, lender coordination, consultant interaction, and complex entitlement.

The economy dipped, the Newport developer shut down his operation, so Alper Development Hunter's Ridge in Fontana was my next challenge, as well as projects in Riverside, Chino Hills, Simi Valley, and Santa Clarita encompassing more than eight hundred residential units.

Alper liquidated and an ad for Land Development Manager for Fortune 500 Developer Toll Brothers prompted a response. The scale of interaction with City, County and State officials, service agencies and environmental consultants accelerated to a whole new level. My area stretched north to south from Ventura to San Diego, west to east from the Coast to the desert. Annual outgo was \$100 million. Improvement scale was enormous.

Re-focusing, private development in the burning desert beckoned. There I planned, contracted, and constructed three additional golf course communities.
